An **ISCC EU and PLUS Basic Training** will take place at the same venue on **July 18 – 20**. The Training will cover all topics relevant for ISCC certification. This includes:

- Implementation and verification of deforestation-free supply chains
- Requirements for traceability and mass balance
- Requirements for greenhouse gas calculations.

There will be a **special focus** of the Training on the:

- Certification of waste-based feedstock, biofuels and supply chains (in particular UCO)
- Export opportunities for waste and residue-based biofuels to EU and the USA
- Upcoming legislative and market developments

The participation in the ISCC EU and PLUS Basic Training is a mandatory requirement for all auditors before they can conduct audits under ISCC. Participation is also recommended to ISCC System Users and companies preparing for ISCC certification.
