Secure and Reliable

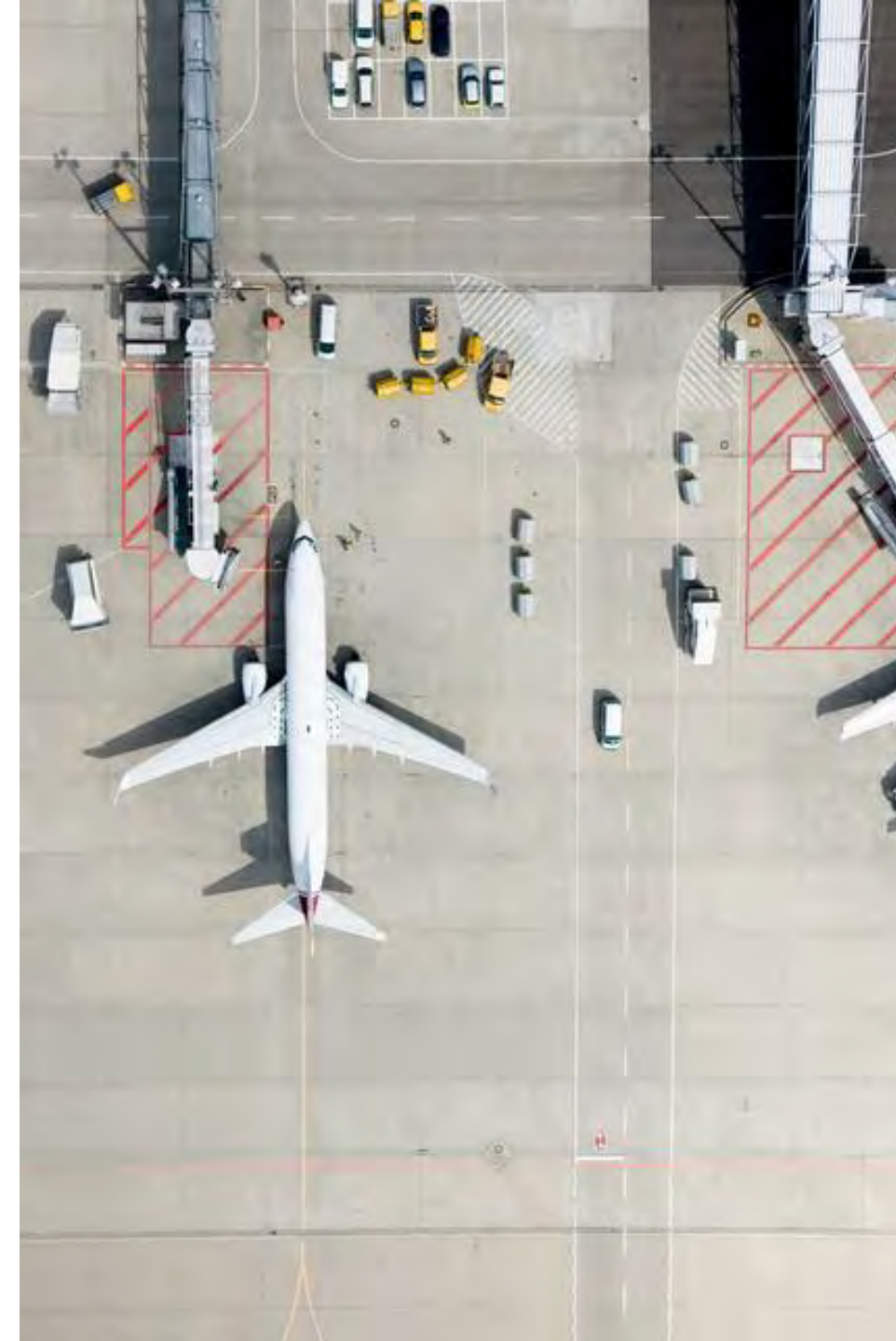
OMV has been active in the aviation business for more than 50 years and therefore have extensive international experience. Our strong regional refining presence and coverage of the entire supply chain with our own resources make us one of the most reliable jet supplier in CEE.

Sustainable and Clean

At OMV, we are shifting the investment to low emission projects > EUR 13 bn until 2030. Our goal is to become a leading European producer of sustainable fuels. We will increase our production capacity to up to 1.5 million tons for renewable fuels and chemical feedstock per year by 2030.

Available and Affordable

The EU's ReFuelEU Aviation regulation is coming into effect, bringing significant changes to the aviation industry but also creating uncertainty. Meeting the increased demand for SAF will present additional hurdles. We all need to work together to overcome these challenges.

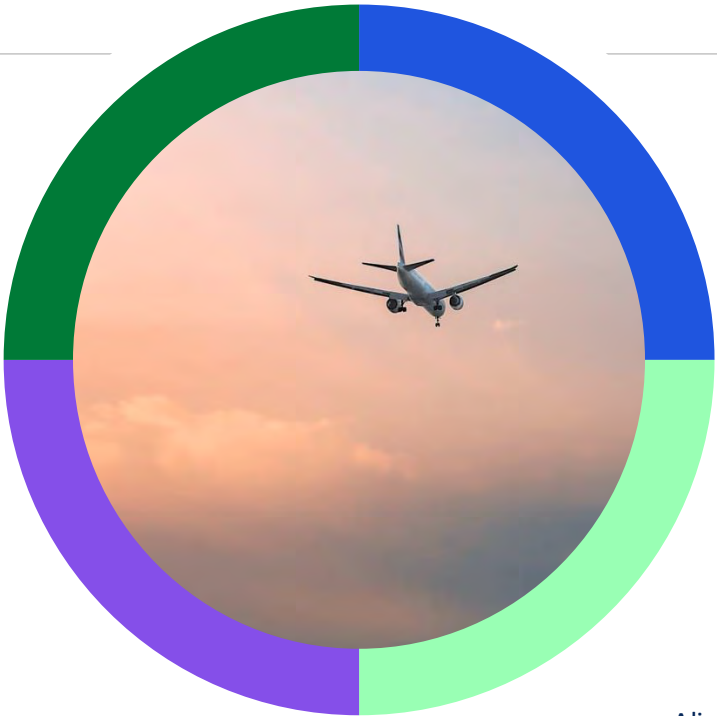

Sustainable aviation fuel (SAF) is a renewable alternative to conventional kerosene fuel that creates more than 80% less carbon emissions over its lifecycle. At our Schwechat refinery, we started to produce 4,000 metric tons p.a. from used cooking oil in 2022 . This volume supports hundreds of flights – the equivalent of 800 to 1,000 flights from Vienna to London – significantly reducing CO2 emissions.

ISCC

We developed “SAF Business Solutions” with ISCC, using a chain-of-custody platform to reliably and verifiably transfer the environmental benefits of SAF via certificates. The platform follows the Book & Claim System, ensuring full traceability, credibility, and demonstrable climate impact.



Microsoft

The newly developed SAF Business solutions are tailored to help organizations accomplish their Scope 3 indirect emission reduction goals, such as from air travel and/or the air transportation of goods. This enables Microsoft to reach its decarbonization targets (Scope 3) and further establish a credible, sustainable corporate air travel and supply chain logistics. .

Airbus

Aligned with the goal of achieving net carbon neutrality in aviation by 2050 this transformative partnership seeks to advance the decarbonization of the aviation industry through SAF. Our strategic partnership focuses on three key areas: SAF demand aggregation, SAF technical leadership and advocacy.
