ISCC PLUS with the Climate Pledge Friendly Programme on Amazon





Eligibility criteria

To ensure full traceability throughout the supply chain, all entities of the supply chain must be ISCC-certified and comply with the scheme's requirements. Companies at the end of the supply chain, such as brand owners, can be covered by ISCC under a certification or a licence, depending on their business activities.

To join the Climate Pledge Friendly programme on Amazon with ISCC PLUS, companies must fulfil the following eligibility criteria:

- 1. The brand owner of the finished goods holds a valid ISCC certificate or licence.
- 2. The product, as opposed to packaging, is linked to ISCC-certified material.
- 3. The ISCC-certified components hold a certified share of 50% or more.
- 4. The finished goods have already launched on the market.

Please note that the programme is currently available in the following marketplaces: The United States, United Kingdom, Germany, France, Italy, Spain, Mexico, Canada, Brazil, Australia, Belgium, Poland, Sweden, and Japan.

Process for ISCC certification and licensing

	How to become ISCC certified	How to become ISCC licensed
Step 1	Choose a certification for your market.	Check the <u>ISCC decision tree</u> to confirm if a licence is eligible for your organisation.
Step 2	Choose a <u>certification body</u> and sign a contract with them.	Apply for the licence via the online application form.
Step 3	Register with ISCC by signing up for the ISCC Client Section and ISCC HUB.	ISCC will internally review your application and may request additional information.
Step 4	Get audited by the certification body and receive an ISCC certificate.	ISCC will send the licence agreements to be signed.
Step 5	After the valid certificate is issued, you can use the ISCC logos and claims, as well as the Climate Pledge Friendly programme on Amazon.	After the effective date in the licence agreement has passed, you can use the ISCC logos and claims, as well as the Climate Pledge Friendly programme on Amazon.
Step 6	Your certificate needs to be annually renewed and will be published in the ISCC certificate database.	The licence renews automatically and requires an annual licence fee. The finished goods with be published in the ISCC licence database .

Next steps for eligible brand owners

- 1. Submit a completed <u>pre-check application form</u> via the ISCC website.
- 2. ISCC will review your application form and get back to you shortly.
- 3. If your application is approved, ISCC will request additional information to complete the submission to the Climate Pledge Friendly programme on Amazon.
- 4. ISCC will then submit your products to Amazon.

ISCC's recommendation for brand owners

To ensure transparency towards the end consumers, ISCC strongly recommends brand owners to communicate details about the chain of custody option, raw material category, certified component, and certified percentage of the finished goods (e.g., through product pictures or descriptions on Amazon).
